NEW BUSINESS:

The Chairman announced that the purpose of this evening's special meeting concerns a personnel matter. The Executive Director, Ann Fangmann, updated the board that following the resignation of Ofelia Resurreccion in July, the Agency actively recruited candidates for p-t position in Section 8. She reported that a large number of applicants applied for the position and that one of the recruits, Ms. Pamela Seaman, demonstrated experience of income certifications having retired from Nassau County DSS. She was looking for a part-time position and was available immediately. Given that Angelina Curcio was going on extended vacation immediately following the time we interviewed and offered Pamela the position, we are seeking approval to hire Pamela effective 8/9/17 with an hourly salary of \$12.50 per hour, not to exceed 20 hour per week. The salary was commensurate with what the outgoing employee was making; therefore, no impact on the budget. The alternative was to close the Section 8 office on the days that Fred Moore was not in the office during Angelina's vacation.
